Agenda Item 12.1: Motion by Councillor Russo to Approve a Draft Plan of Subdivision for Brookvalley Development (part of pre-zoned Block A4)

This motion is being tabled at Tuesday's Planning and Development Committee Meeting,

We urge you to attend or livestream this meeting, **and more critically to contact Mayor Groves and Councillor Russo to request they pull the motion.**

This motion should NOT be approved because:

It is within one of the Mayor's 12 Zoning By-Law areas that is before the Court

It's totally premature due to incomplete studies for major issues that remain unresolved, such as:

- traffic flow and connections to Hurontario St and Chinguacousy Rd
- Greenbelt and significant valleyland crossings
- conflict with the proposed Highway 413

Councillor Russo seeks to by-pass Town Staff and have this approved with NO staff report

The question to ask:

Why is Councillor Russo, who represents Wards 3, 4, and 5, bringing forward this motion for land in Ward 2?

Doesn't it seem strange that he's involved in a development that's NOT in his ward?

Again, this demonstrates that the Mayor and her allies do not have the interests of Caledon's residents and taxpayers in mind, but rather those of the development industry.
